- A. SECTION 09 68 13 Tile Carpeting: Page 09 68 13-3:
 - 1. DELETE paragraph 2.1 in its entirety and replace with the following: "See Flooring Legend on drawings."

DRAWINGS

- A. SHEET A-101, A-102, A-103, A-104, A-105, A-106, A-107, A-108: FLOORING LEGEND:
 - 1. REVISE Carpet Tile Specification as Follows: "New Carpet Tile: Shaw Contract Group, Style: Charisma Tile, 59561, color as selected by the PHA from the manufacturer's full line of available colors."
- B. SHEET A-401: Interior Door Detail 1C/A-401:
 - 1. REVISE header dimension to read :1'-2".
 - 2. ADD the following note: Demo door header construction where existing and reconstruct per detail 1C/A-401.
