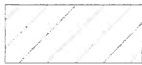

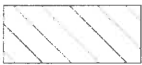

EXISTING CARPET AND GLUE TO BE REMOVED BY ABATEMENT CONTRACTOR. ALL WALL BASE MATERIAL AND WALL BASE MASTIC TO BE REMOVED. CARPET, CARPET GLUE, WALL BASE AND WALL BASE MASTIC MAY BE DISPOSED OF AS NON-ASBESTOS WASTE.



EXISTING CARPET AND TACK STRIPS TO BE REMOVED BY ABATEMENT CONTRACTOR. ALL WALL BASE MATERIAL AND WALL BASE MASTIC TO BE REMOVED. CARPET, WALL BASE AND WALL BASE MASTIC MY BE DISPOSED OF AS NON-ASBESTOS WASTE. UNDERLYING FLOOR TILE AND FLOOR TILE MASTIC TO BE ABATED AND LEGALLY DISPOSED OF AS ASBESTOS WASTE.
