- 3. At Section **00 21 14** (Instructions to Bidders), page 8, paragraph FF, the date of "July 15, 2024" to be removed from the first two sentences. In the first sentence, replace with "a scheduled completion date, 90 days from contract execution." In the second sentence, replace with "the scheduled completion date."
- 4. At Section **00 52 14** (Agreement Form AIA), page 1, paragraph 1.2/D./1. the date of "July 15, 2024" to be removed from the first two sentences. In the first sentence, replace with "a scheduled completion date, 90 days from contract execution." In the second sentence, replace with "the scheduled completion date."
- 5. At Section **08 71 00** (Door Hardware), page 33, for Hardware Group No. 09.01 (at Door B11-1 Evidence Storage Room) Add Note that this Door is to be off of the master keying system.
- 6. At Section **09 65 13** (Resilient Base and Accessories), pages 2-3, remove paragraph 2.1 "LUXURY VINYL TILE FLOORING".
- 7. At Section **09 65 13** (Resilient Base and Accessories), page 4, at paragraph 2.3 "ACCESSORIES" add Item E. "Stair Nosings: Manufacturer's standard for selected flooring, color chosen by Architect from manufacturer's full color range."
