  - c. **Bid Opening – Tuesday, April 30, 2024** (time and location to remain as shown)
3. At Section **00 21 14** (Instructions to Bidders), page 9, remove all of Section 1.6, paragraphs A, B, and C – **REQUIRED CONTRACTOR/SUBCONTRACTOR BACKGROUND SCREENING.**
4. At Section **09 65 13** (Resilient Base and Accessories), pages 2-3, restore paragraph 2.1 – **“LUXURY VINYL TILE FLOORING”** – which was removed in Addendum 01.

1. At Sheet **A-101**, New Flooring Notes below First Floor Plan, Change “New Flooring” at Rooms 103 (350+/- SF) and 104 (255+/- SF) from Carpet Tile to LVT.
2. At Sheet **A-601**, on Room Finish Schedule, at Rooms 103 and 104, show “LVT” for Flooring. Add note below schedule that LVT = Luxury Vinyl Tile.
