41. Revise Specification 00 21 14 – Instructions to Bidders, Section 1.4 paragraph D. Latest Time to Issue an Addendum: to May 30, 2024 by 4:30 PM
42. Revise Specification 32 31 23 – Extruded Vinyl Fencing Systems to remove any reference to “wood grain”

DRAWINGS

43. C- 501 remove all references to “FENCE BASIS-OF-DESIGN: CERTAINTEED – CHESTERFIELD WITH CERTAGRAIN TEXTURE”.
44. C-501 remove all references to posts being set in sleeves anchored in concrete for ease of replacement. All extruded vinyl fence to be installed per manufacturer’s instructions.

CLARIFICATIONS

45. Extruded Vinyl Fence basis of design is the Illusions Vinyl Fence V500. It should be an 8’-0 tall, semi-private panel of manufacturers standard classic colors as chosen by A/E or Owners representative. Boards are to be 3” x 7/8” with small spaces between. A wood grain finish is not desired. Fence system to be installed per manufacturers instructions in compliance with any relevant codes addressing structural requirements.
