 - 1. **ADD** the following to the Paragraph related to liquidated damages, “Material lead times (documented by dated proof of order placement and written statements from manufacturer of material for reasons behind delay) and weather days (as agreed upon by Owner, A/E and Contractor) will not be grounds for enforcing liquidated damages.”
