1. REVIEW OF PROJECT DOCUMENTS – SPECIFICATIONS / DRAWINGS

- Reviewed Invitation to Bid and Instructions to Bidders. Architect to review Certified Payrolls.
- Reviewed Alternate 1: Entirety of Work on Shawneetown Unit 123 (123 West Wilson), while Base Bid is Entirety of Work at Unit #5 and Unit #8 in Ridgway.
- c. Reviewed Roofing Work.
- d. Reviewed Wall Reinforcement Work.

Drawing items to correct noted.

In discussing SW-1 (requires only one Hold-down at each end and wall patch/paint) and SW-2) (also requires additional studs, interior sheathing, additional anchors, and gyp. board & paint over new sheathing), we determined that length of each SW-2 and any wall-mounted devices on SW-2 would be necessary for bidding purposes.

- e. Known/anticipated Addendum 1 items noted: drywall thickness to match existing at patch locations, modified structural note, approved equal standing seam roof.
- f. Discussed schedule. Long lead-times are not

anticipated for either trusses or metal roofing components

 g. Concluded indoor meeting and went to review work sites.

2. WALK-THROUGH OF PROJECT SITES

- a. 123 West Wilson, Shawneetown (Alternate 1):
 - Outside areas measured at SW-2 locations and interior surfaces checked for wall-mounted devices. Measurements are not accurate descriptions of SW-2, but give an approximation.

ii. Question of whether existing fascia metal could remain. Found (2) at ~32" w/ no electrical, and (2) at ~49" with (2) outlets ea.

Not at this point, but open to it.

- b. Unit 5, Ridgway:
 - Outside areas measured at SW-2 locations and interior surfaces checked for wall-mounted devices. Measurements are not accurate descriptions of SW-2, but give an approximation.

ii. Review of Site and Staging.

Found (2) at ~45" with (1) switch and (1) outlet, and (2) at ~48" w/ no electrical.

c. Unit 8, Ridgway:

i. Review of Site and Staging.

Noted that staging would work better from the north, due to trees.

Noted that staging would work better from the north and west, due to low power lines to south.

d. Walk-thru concluded at approximately 12:00 noon.
